## **FBFC Code of Ethics**

- ✦ **My goal in breeding French Bulldogs will be to improve the breed.**
- ✦ **I will refuse to provide stud service to any bitch that lacks the quality to produce sound, healthy pups that meet the Standard of the Breed.**
- ✦ **I will sell on a spay/neuter contract any dog which has faults which would be detrimental to the breed.**
- ✦ **I will not engage in the sale or resale of any French Bulldogs, other than those owned, co-owned or bred by myself.**
- ✦ **I will test all breeding stock in my breeding program for any known genetic defects which afflict my breed.**
- ✦ **I will protect an Agreement with another breeder or persons by having all paperwork prepared in duplicate and signed by both parties, with each party retaining a copy.**
- ✦ **I will respond to any written complaint regarding a dog sold by me in a timely manner.**
- ✦ **I will not misrepresent any puppy or dog to the purchaser, nor will I use misleading or untruthful statements in selling or advertising.**
- ✦ **Moneys deposited with me to hold a puppy or dog for an agreed upon time constitutes a binding agreement to which both parties are committed.**
- ✦ **I will not sell or donate dogs to commercial dog wholesalers or retailers (puppy mills or pet shops) nor to those that do so. I will report to the Canadian Kennel Club any breeder that I know of who does.**
- ✦ **I will maintain high standards in the care of my dogs and will comply with all Canadian Kennel Club regulations.**
- ✦ **At the time of sale, I will furnish records to each buyer which include the following: shots and worming, three or more generation pedigree, and diet and care information.**
- ✦ **I will help the new owner for the entire life of the dog.**
- ✦ **I will not degrade other breeders, other dogs or other breeding programs.**
- ✦ **If I have reservations about them, my refusal to comment will be sufficient.**
- ✦ **I will to the best of my abilities, donate a portion of all puppy sales to the Club's Rescue, if only as little as \$1 from each sale.**
- ✦ **I will endeavour to conduct myself at all times in a manner that will reflect favourably on my breed, those who have entrusted me with their dogs and on the sport of purebred dogs in general.**
- ✦ **I agree to use respect and dignity when communicating with, or about my fellow members. Any differences of opinion will be discussed in a professional manner and in an appropriate venue. I understand that the Board of Directors has the authority to suspend and/or cancel my membership in the FBFC should I fail to act accordingly.**

**I realize that, as a member of the French Bulldog Fanciers of Canada, I am required to abide by the above code of ethics at all times, and that my failure to do so may result in my loss of membership and club privileges.**
